AMENDMENT TO H.R. 836 OFFERED BY MR. AL GREEN OF TEXAS [Emergency Mortgage Relief Program Termination Act]

In section 2, strike "Effective on the date of the enactment of this Act" and insert the following: "(a) IN GENERAL.—Effective upon submission to the Congress, by the Secretary of Housing and Urban Development, of the notice required under subsection (b)".

In section 2, strike "such date of enactment" and insert "date of submission of such notice".

In section 2, before the period at the end insert the following: ", less the amount specified in such notice of the Secretary of Housing and Urban Development".

At the end of section 2, add the following new subsection:

1 (b) **IDENTIFICATION** OF AMOUNTS FOR 2 **REFINANCINGS FOR ELIGIBLE HOMEOWNERS.**—The Sec-3 retary of Housing and Urban Development, in consultation with the Secretary of Defense and the Secretary of 4 Veterans Affairs, shall determine, of the unobligated bal-5 ances described in subsection (a), the amount necessary 6 7 to provide assistance under title I of the Emergency Hous1 ing Act of 1975 (12 U.S.C. 2701 et seq.) to eligible home2 owners (as such term is defined in section 3(d)(2) of this
3 Act). Not later than the expiration of the 180-day period
4 beginning on the date of the enactment of this Act, the
5 Secretary of Housing and Urban Development shall sub6 mit notice of such determination to the Congress that
7 specifies such amount.

In section 3(b), before "shall continue" insert the following: ", and any amounts made available for use under such Program that remain available for use in accordance with subsection (d),".

At the end of section 3, add the following new subsection:

8 (d) CONTINUATION OF PROGRAM FOR MEMBERS OF
9 THE ARMED FORCES, VETERANS, AND GOLD STAR RE10 CIPIENTS.—

11 (1) USE OF UNRESCINDED AMOUNTS.—The 12 amounts identified in the notice of the Secretary of 13 Housing and Urban Development required under 14 section 2(b) shall be used under the Emergency 15 Mortgage Relief Program under the provisions of 16 law referred to in subsection (a) of this section only 17 to provide assistance under such Program for eligi-18 ble homeowners.

1	(2) ELIGIBLE HOMEOWNER.—For purposes of
2	this subsection, the term "eligible homeowner"
3	means a homeowner who is—
4	(A) a member of the Armed Forces of the
5	United States on active duty or the spouse or
6	parent of such a member;
7	(B) a veteran, as such term is defined in
8	section 101 of title 38, United States Code; or
9	(C) eligible to receive a Gold Star lapel pin
10	under section 1126 of title 10, United States
11	Code, as a widow, parent, or next of kin of a
12	member of the Armed Forces person who died
13	in a manner described in subsection (a) of such
14	section.
