- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Bureau of Consumer
- 5 Financial Protection Transfer Clarification Act".

1 SEC. 2. DIRECTOR REQUIRED BEFORE TRANSFER.

- 2 Section 1062 of the Dodd-Frank Wall Street Reform
- 3 and Consumer Protection Act is amended by adding at
- 4 the end the following new subsection:
- 5 "(d) DIRECTOR REQUIRED BEFORE TRANSFER.—
- 6 Notwithstanding the other provisions of this section, the
- 7 single calendar date for the transfer of functions to the
- 8 Bureau under section 1061 shall be the later of—
- 9 "(1) the date that would have been designated,
- but for the application of this subsection; and
- "(2) the date on which the Director of the Bu-
- reau is confirmed by the Senate pursuant to section
- 13 1011(b).".
