

**AMENDMENT TO THE COMMITTEE PRINT OF THE
BUDGET RECONCILIATION LEGISLATIVE REC-
COMMENDATIONS OF THE COMMITTEE ON FI-
NANCIAL SERVICES**

OFFERED BY MR. MILLER OF NORTH CAROLINA

Page 13, beginning on line 8, strike **“Bureau of Consumer Financial Protection”** and insert **“Financial Regulator’s Budgets”** (and conform the table of contents accordingly).

Page 14, after line 11, insert the following (and conform the table of contents accordingly):

1 **SEC. 332. BRINGING THE OFFICE OF THE COMPTROLLER**
2 **OF THE CURRENCY INTO THE REGULAR AP-**
3 **PROPRIATIONS PROCESS.**

4 (a) IN GENERAL.—The Revised Statutes of the
5 United States is amended by inserting after section 5240A
6 the following new section:

7 **“SEC. 5240B. AUTHORIZATION OF APPROPRIATIONS; FEES**
8 **USED TO RECOVER THE COST OF APPRO-**
9 **PRIATIONS.**

10 **“(a) AUTHORIZATION OF APPROPRIATIONS.—There**
11 **are authorized to be appropriated to the Comptroller of**

1 the Currency such sums as may be necessary to carry out
2 the responsibilities of the Office of the Comptroller of the
3 Currency.

4 “(b) FEES USED TO RECOVER THE COST OF APPRO-
5 PRIATIONS.—

6 “(1) IN GENERAL.—Notwithstanding any other
7 provision of law, all assessments, fees, or charges
8 collected by the Comptroller of the Currency—

9 “(A) shall be deposited into the General
10 Fund of the Treasury and credited as offsetting
11 appropriations to the account providing appro-
12 priations to the Office of the Comptroller of the
13 Currency; and

14 “(B) shall not be collected for any fiscal
15 year except to the extent provided in advance in
16 appropriation Acts.

17 “(2) FEE RATE ADJUSTMENTS.—The Comp-
18 troller of the Currency shall adjust the assessments,
19 fees, and charges collected by the Comptroller in a
20 given fiscal year such that the aggregate amount of
21 all such assessments, fees, and charges, are equal to
22 the amount appropriated to carry out the respon-
23 sibilities of the Office of the Comptroller of the Cur-
24 rency for such fiscal year.”.

1 (b) TREATMENT OF REMAINING AMOUNTS IN AS-
2 SESSMENT FUND.—Assessments, fees, and charges col-
3 lected by the Comptroller of the Currency and not ex-
4 pended, as of the date of the enactment of this Act, shall
5 be deposited into the General Fund of the Treasury.
