3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the " Act
5	of 2016".

1	SEC. 2. HOUSING CHOICE VOUCHER MOBILITY DEM-
2	ONSTRATION.
3	(a) Authority.—The Secretary of Housing and
4	Urban Development (in this section referred to as the
5	"Secretary") may carry out a mobility demonstration pro-
6	gram to authorize public housing agencies to administer
7	housing choice voucher assistance under section 8(o) of
8	the United States Housing Act of 1937 (42 U.S.C.
9	1437f(o)) in a manner designed to encourage families re-
10	ceiving such voucher assistance to move to lower-poverty
11	areas and expand access to opportunity areas.
12	(b) Selection of PHAs.—
13	(1) LIMITATION.—The Secretary shall establish
14	competitive selection criteria and requirements for
15	public housing agencies to participate in the dem-
16	onstration program under this section, and may ap-
17	prove not more than 10 regional housing mobility
18	programs established by public housing agencies for
19	such participation.
20	(2) RANDOM SELECTION OF FAMILIES.—The
21	Secretary may require participating agencies to use
22	a randomized selection process to select among the

6	Public housing agencies participating in the demonstra-
7	tion program under this section may use administrative

10	serves, and funding from private entities to provide mobil-
11	ity-related services in connection with the demonstration
12	program, including services such as counseling, portability
13	coordination, landlord outreach, and administrative activi-
14	ties associated with establishing and operating regional
15	mobility programs.
16	(e) Waivers.—
17	(1) Authority.—The Secretary may waive or
18	specify alternative requirements for any provision of
19	subsection (o), (r), or (x) of section 8 of the United
20	States Housing Act of 1937 (42 U.S.C. 1437f), ex-
21	cept for requirements related to fair housing, non-
22	discrimination, or the environment, upon a finding
23	that such waiver or alternative requirement is nec-
24	essary to implement and administer a Plan.

1	(2) Notice.—Any such waiver or alternative
2	requirement shall not take effect before the expira-
3	tion of the 10-day period beginning upon the Sec-
4	retary publishing notice in the Federal Register of
5	such waiver or alternative requirement.
6	(f) Implementation.—The Secretary may imple-
7	ment the demonstration, including its terms, procedures,
8	requirements, and conditions, by notice.
9	(g) EVALUATION.—Not later than three years after
10	implementation of the regional housing mobility programs
11	under the demonstration program under this section, the
12	Secretary shall submit to the Congress and publish in the
13	Federal Register a report evaluating the effectiveness of
14	the demonstration, subject to the availability of funding

15 to conduct the evaluation.
