SURANCE COMPANIES BY THE FDIC RATHER THAN
STATE AUTHORITIES.—With respect to an insurance
company, upon the Secretary making a determina-
tion in accordance with section 1603(b), there shall
be a strong presumption against the appointment of
the Corporation as receiver or qualified receiver by
the Secretary, and the resolution of the insurance
company in question shall be bound by the applica-
ble laws of the State in which the company is domi-
ciled. The presumption may be overcome only if the
Secretary, the Federal Reserve Board, and the Cor-
poration, in consultation with the insurance commis-
sioner of the State in which the company is domi-
ciled, agree that the appointment of the Corporation
as receiver or qualified receiver is necessary to avoid
