3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Bureau of Consumer  
5 Financial Protection Examination and Reporting Thresh-  
6 old Act of 2017”.

1 **SEC. 2. INCREASE IN THE EXAMINATION THRESHOLD.**

2 Section 1025(a) of the Consumer Financial Protec-  
3 tion Act of 2010 (12 U.S.C. 5515(a)) is amended by strik-  
4 ing “\$10,000,000,000” each place that term appears and  
5 inserting “\$50,000,000,000”.

6 **SEC. 3. INCREASE IN THE REPORTING THRESHOLD.**

7 Section 1026(a) of the Consumer Financial Protec-  
8 tion Act of 2010 (12 U.S.C. 5516(a)) is amended by strik-  
9 ing “\$10,000,000,000” each place that term appears and  
10 inserting “\$50,000,000,000”.

11 **SEC. 4. EFFECTIVE DATE.**

12 This Act and the amendments made by this Act shall  
13 take effect on the date that is 45 days after the date of  
14 enactment of this Act.
