Page 5, after line 2, insert the following:

1 (h) MATCHING REQUIREMENT.—Notwithstanding
2 any other provision of this section, the amount of assist-
3 ance provided pursuant to this section for any public hous-
4 ing agency may not exceed the aggregate amount that the
5 State or local governments served by the agency will pro-
6 vide, based on such assurances as the Secretary shall re-
7 quire, to supplement assistance amounts provided pursu-
8 ant to this section and which may be used only for the
9 same purposes for which such assistance amounts may be
10 used.

Page 5, after line 18, insert the following:

11 (c) MATCHING REQUIREMENT.—Notwithstanding
12 any other provision of this section, the amount of assist-
13 ance provided pursuant to this section for a recipient may
14 not exceed the aggregate amount that the State or local
15 government in which the housing of the recipient is located
16 will provide, based on such assurances as the Secretary
17 shall require, to supplement assistance amounts provided

1 pursuant to this section and which may be used only for
2 the same purposes for which such assistance amounts may
3 be used.

Page 6, after line 10, insert the following:

4 (d) MATCHING REQUIREMENT.—Notwithstanding
5 any other provision of this section, the amount of assist-
6 ance provided pursuant this section for a State or local
7 government may not exceed the aggregate amount that the
8 State or local government will provide, based on such as-
9 surances as the Secretary shall require, to supplement as-
10 sistance amounts provided pursuant to this section and
11 which may be used only for the same purposes for which
12 such assistance amounts may be used.

Page 7, after line 6, insert the following:

13 (c) MATCHING REQUIREMENT.—Notwithstanding
14 any other provision of this section, the amount of assist-
15 ance provided pursuant to this section for an eligible re-
16 cipient may not exceed the aggregate amount that the
17 State or local governments served by the recipient will pro-
18 vide, based on such assurances as the Secretary shall re-
19 quire, to supplement assistance amounts provided pursu-
20 ant to this section and which may be used only for the
21 same purposes for which such assistance amounts may be
22 used.

Page 7, after line 20, insert the following:

1 (c) MATCHING REQUIREMENT.—Notwithstanding
2 any other provision of this section, the amount of assist-
3 ance provided pursuant to this section for a borrower or
4 recipient may not exceed the aggregate amount that the
5 State or local government in which the housing of the bor-
6 rower or recipient is located will provide, based on such
7 assurances as the Secretary shall require, to supplement
8 assistance amounts provided pursuant to this section and
9 which may be used only for the same purposes for which
10 such assistance amounts may be used.

Page 8, after line 10, insert the following:

11 (c) MATCHING REQUIREMENT.—Notwithstanding
12 any other provision of this section, the amount of assist-
13 ance provided pursuant to this section for a recipient for
14 an Indian tribe may not exceed the aggregate amount that
15 the recipient will provide, based on such assurances as the
16 Secretary shall require, to supplement assistance amounts
17 provided pursuant to this section and which may be used
18 only for the same purposes for which such assistance
19 amounts may be used.

Page 8, after line 23, insert the following:

20 (c) MATCHING REQUIREMENT.—Notwithstanding
21 any other provision of this section, the amount of assist-

1 ance provided pursuant to this section for a participating
2 jurisdiction may not exceed the aggregate amount that the
3 participating jurisdiction will provide, based on such as-
4 surances as the Secretary shall require, to supplement as-
5 sistance amounts provided pursuant to this section and
6 which may be used only for the same purposes for which
7 such assistance amounts may be used.

Page 9, after line 16, insert the following:

8 (e) MATCHING REQUIREMENT.—Notwithstanding
9 any other provision of this section, the amount of assist-
10 ance provided pursuant to this section for recipient may
11 not exceed the aggregate amount that the State or local
12 governments in which the housing of the recipient is lo-
13 cated will provide, based on such assurances as the Sec-
14 retary shall require, to supplement assistance amounts
15 provided pursuant to this section and which may be used
16 only for the same purposes for which such assistance
17 amounts may be used.

Page 10, after line 20, insert the following:

18 (d) MATCHING REQUIREMENT.—Notwithstanding

21 not exceed the aggregate amount that the State or local
22 governments in which the housing of the recipient is lo-

4 only for the same purposes for which such assistance
5 amounts may be used.

Page 11, after line 8, insert the following:

6 (c) MATCHING REQUIREMENT.—Notwithstanding

8 ance provided pursuant to this section for a recipient may
9 not exceed the aggregate amount that the State or local
10 governments served by the recipient will provide, based on
11 such assurances as the Secretary shall require, to supple-
12 ment assistance amounts provided pursuant to this section
13 and which may be used only for the same purposes for
14 which such assistance amounts may be used.

Page 15, after line 7, insert the following:

15 (g) MATCHING REQUIREMENT.—Notwithstanding
16 any other provision of this section, the amount of assist-
17 ance provided pursuant to this section for a State, unit
18 of general local government, or Indian tribe may not ex-
19 ceed the aggregate amount that the State, unit of general
20 local government, or Indian tribe will provide, based on
21 such assurances as the Secretary shall require, to supple-
22 ment assistance amounts provided pursuant to this section

- 2 which such assistance amounts may be used.
